The Honorable Frank J. Bailey U.S. Bankr. Judge (ret.)



PioneerLegal challenged the refusal by Massachusetts to allow students enrolled in public virtual schools to participate in sports in their home districts. The state had allowed such participation for years, but the entity that controls high school sports for the state changed its position in May 2022. Students in state virtual schools are often those that were bullied or have anxiety disorders. The case involves at least 55 potential student athletes and is now pending in state court and class action certification is sought.

PioneerLegal condemns "equity theft" whereby municipalities, including in New England, foreclose on real estate tax liens and then pocket the homeowner's equity in the property that can exceed the taxes due by tens of thousands of dollars. In a brief filed with the U.S. Supreme Court, PioneerLegal urged the Court to find that laws that permit municipalities to take a homeowner's equity, often people that are unwell or aged, are unconstitutional.

DOR overreach. PioneerLegal filed an amicus brief with the SJC arguing that the Commissioner's imposition of a capital gains tax disincentivizes private investment in blighted property that would add needed affordable housing. Moreover, the Commissioner's imposition of a capital gains tax is directly contrary to the plain statutory language promising tax break for private redevelopment of vacant and dilapidated property.

PioneerLegal weighs in against Mass



#### PioneerLegal urges the Massachusetts Supreme Judicial Court to rein in the Commissioner of Revenue from applying questionable regulations retroactively. An online seller of auto parts from California was shocked to learn that because it used computer "cookies" when offering products in the state it was required to files sales tax returns and to submit those taxes to the DOR. The constitutionality of the socalled "cookie nexus" will arise in future cases, but in this case the Commissioner took an aggressive position that allowed him to apply a new regulation retroactively. Such a position can easily be abused in the future.

#### PioneerLegal sues to gain access to MBTA arbitrator's decision. In the wake of the dismal safety and operations record of the MBTA in recent months, the MBTA won a critical arbitration case regarding pension rights against the union. The union and MBTA have refused to permit access to the opinion, which interferes with the public's right to comment on the validity of the appeal. PioneerLegal argues a refusal to disclose the opinion on which the union has appealed is a violation of law.

#### PioneerLegal defends the right a senior citizen to be heard at a select board meeting in Southborough, MA.

Where are free speech rights more sacrosanct than at a town meeting? Louise Barron, a senior citizen and long-time resident of Southborough, stood up during the open comment period and raised her concerns about the town budget and the town's documented abysmal record on Open Meeting Law compliance. But she was abruptly silenced by the chairman, who relied on a newly adopted rule prohibiting "rude, personal, inappropriate, or slanderous" speech. Louise's comments before being shut off were none of these — they were, however, uncomfortable for the chairman to hear.

## Civics Education in Massachusetts

**Schools.** In 2018, Governor Baker signed the Bill to Promote Civic Education for students in our schools. The bill is focused on requiring some civics education at



all grade levels and a more intensive engagement at the eighth-grade level. It was to promote student abilities to understand and analyze a variety of perspectives and to help students understand the interaction of federal, state, and local governments. The Massachusetts Department of Elementary and Secondary Education directed that schools begin implementing the History and Social Science Curriculum Framework and student-led civics projects in 2019–2020, and that student-led civics projects be fully implemented in all schools by 2020–2021. PioneerLegal is testing the implementation of the bill and exploring whether litigation might be required to ensure that critical civics education is hitting the classroom.



#### Cutting the Red Tape.

Massachusetts and Boston in particular have been identified as among the least friendly places in the US to start a small business. Permits, licenses, inspections, and other barriers are both time-consuming and expensive, leading many entrepreneurs to just give up. There is also evidence that during

the Covid-19 shutdown this situation has worsened. PL is working to identify a litigation or advocacy solution.

**Public Records and the Legislature.** Massachusetts is among the few states exempts the legislature from the application of the public records and open meetings laws. We at PL believe the state constitution preserves the right of citizens to be informed about the legislative process. We are exploring whether there is a litigation challenge that might open the legislative process to public inspection. We seek to let the sunshine in!

Frank Bailey Appears on Pioneer's HUBWONK podcast.
